STUDENT TUITION FEE

Student Involvement in Determining New Student Tuition Fee

The involvement of students (who are members of the Verifier Team) in determining the tuition fee of new students is considered insufficient. When the hearing was held, the team had not yet received a decree so there was no solution if the verification schedule collided with class time.

To overcome this, the number of students in the Verifier Team will be increased to 7-12 people. Students are also expected to be involved in field surveys to ensure the validity of the files sent by freshmen. New students who are proven to manipulate data can resign as UGM students.

STUDENT TUITION FEE

Tuition Fee Appeal

The Ministry of Action and Propaganda (Akspro) conducted a small survey of new FIB 2024 students. As a result, 3% of 54 new students who appealed UKT were dissatisfied with the results of the appeal.

The dean has carefully scrutinized the data of new students who make appeals. To ensure the authenticity of the data, the Verifier Team can also conduct an interview session before determining the appeal result.

UKT appeals can also be made by non-new students, called "Waivers with a Certain Percentage" which can be submitted every semester through Simaster. Technically, verification of this waiver data will go through two stages, namely carried out by the study program and reviewed again by the faculty.

STUDENT TUITION FEE

Institution Development Fee (IPI)

The implementation of IPI is only intended for new students who qualify through the Independent Selection pathway and get a superior UKT category or 0% subsidy. IPI is only paid once during the college period and can be paid in installments a maximum of two times according to predetermined conditions.

Change in UKT Nominal

This year, the Cultural Anthropology and History study programs experienced changes in the UKT nominal. The nominal UKT for students in the 2024/2025 academic year decreased compared to the 2023/2024 year. This provision was only issued after the payment period for new SNBP 2024 students. Therefore, students who have already paid the old nominal will be contacted and returned the excess funds.

NEW BUILDING ISSUE

During the construction of the new building, the rooms affected by the construction will be attempted to be moved. It is planned that the unusable lecturer rooms in Margono Building will be used as BSO and LEM Secretariat, Building G downstairs can be used for storage space, or can also be used as a Co-Working Space, FIB Library is in negotiations to be moved to the first floor of GSP, other plans, Co-Working Space and Music Studio will be moved to Pusaka Jawa.

Classes will strive to last only until the afternoon. However, if this is not possible, evening classes will be held. Student activities will be held on Saturdays. Student activities at night can be carried out until 10 pm, this regulation will be implemented in the odd semester of 2024.



- For BSOs that do not have a secretariat room, the plan is to use the Javanese Heritage building with adequate facilities such as a soundproof room, stage, open space, and so on.
